Cascade Bucket System Warranty

Kawak Aviation Technologies, Inc. (hereinafter referred to as “the Company”) hereby provides a warranty for the Kawak Cascade water bucket systems (hereinafter referred to as “the Product”) for a duration of one year from the date of purchase, subject to the following terms and conditions:

- 1. The Company’s obligation under this warranty is solely confined to the repair or replacement, at the Company’s discretion, of any product proven to be defective.*
- 2. The Company warrants that its products are free from defects in workmanship and material for a period of one year for the original purchaser.*
- 3. The Company must receive written notification of any warranty claims from the original purchaser, detailing the claimed defect in the product.*
- 4. For warranty repair claims, the product must be returned to the Company for inspection, with all transportation and duty charges prepaid by the claimant.*
- 5. This warranty does not cover any product that has been damaged accidentally, abraded, altered, punctured, or subjected to misuse.*
- 6. This warranty becomes null and void if the product is not installed, used, and/or maintained in accordance with the operations manual and instructions provided by the Company.*
- 7. The Products are designed and manufactured with safety margins exceeding the designed maximum loads. The user is responsible for maintaining the bucket to a safe standard.*
- 8. This warranty is provided exclusively to the original purchaser of the Product and does not extend to any subsequent purchaser or assignee.*
- 9. No warranties, either implied or assumed, exist beyond the warranty issued by the Company.*
- 10. The Company disclaims all liability for personal injury or property damage resulting from incorrect operation or deployment of the Product by the customer.*
- 11. To the extent permissible under applicable law, the Company expressly disclaims liability for consequential and incidental damages. The Company’s liability for all events is limited to, and shall not exceed, the purchase price paid for a Cascade bucket system.*
